1. Call to Order

Mr. Myers asked what it would cost to flatten the roof at the old planetarium area rather than just insulate that area and Dr. Roberts said we could get someone to give us an estimate and discuss that option.

Mr. Over asked if the amount for the middle school generator project is for wiring only which Mr. Statler confirmed. Mr. Over asked if HVAC is necessary, and Dr. Roberts stated it is important because AV closets contain electronic equipment that is important to not become overheated. Mr. Statler confirmed the cost is to run wiring only since we already own the generator.

Dr. Roberts stated the soundproofing project at the Newville cafeteria would give them the ability to hold health and physical education classes on the opposite side of the gym while lunch is being served.

Dr. Roberts shared that educationally, we may resume talks to consider an elementary grade re-configuration which would pair nicely with 2023/2024 construction projects.

Dr. Roberts stated we utilized an ESCO about 10 years ago when they evaluated our systems and guaranteed our savings. Mr. Swanson stated change orders from architects have taken us by surprise over the years, but an ESCO would eliminate change order costs by guaranteeing the project cost upfront.
