#### 2. Presentation:

#### 2.a. Mr. Nolan Marx - ProtectEd - WellAir Portable Air Disinfection

Mr. Marx presented information on the WellAir portable air disinfection device produced by ProtectEd which eliminates microorganisms of any size and inactivates viruses and pathogens at the DNA level.

Mr. Piper asked if the coils that destroy the contaminates need to be replaced and Mr. Marx responded they do not.

Mr. Wardle asked how the device controls particles such as flu or COVID and Mr. Marx responded that the unit is very effective with those pathogens.

Mr. Over asked which specific brands had been considered and Dr. Roberts explained that dry hydrogen systems have recurring costs. He stated that because the purchase would be made from grant funds it would be better to incur the costs upfront rather than have ongoing costs such as bipolar iozination systems or the Reme Halo unit which would require UV light replacement costs down the road.
