# **2.a.** Cumberland Perry Area Career and Technical Center Renovation Project - Mr. Justin Bruhn, Administrative Director

Justin Bruhn provided a Renovation Project presentation to the Committee of the Whole:

Mr. Over asked our enrollment at CPACTC and Mr. Bruhn said Big Spring is sending 130 students to Cumberland Perry. Mr. Over asked how many school districts participate and Mr. Bruhn responded 13. Mr. Over asked if Big Spring is paying 10% of the future construction cost and Mr. Bruhn said Big Spring has historically sent over 10% of the population of our students. Mr. Over asked if Big Spring's quota is going to go up and Mr. Bruhn stated quotas are determined by a mathematical formula and said projected new seats will be distributed according to the formula which includes district size in relation to the other districts.

Mr. Myers asked if Big Spring doesn't use their quota could another school district use that spot and Mr. Bruhn said that happens but we try to be fair but also consider the areas of interest by the applicants. He stated it's not a perfect science putting students into slots. He also said we have a student return rate of 82 – 85% but we never know who we'll lose from a given program.

Mr. Piper said rest assured based on past and future history, I don't think our quota will go down in the future and Mr. Over said he would hope and expect it to go up.
