#### II. DISCUSSION ITEMS

#### A. Middle School Tunnel Dehumidification Remediation

## B. <u>High School Roof Replacement Pool/Mechanical Room</u>

Mr. Rick Gilliam reminded the Board that Mr. Marc Harder discussed the High School Roof project with the Board at the last Board meeting. Mr. Gilliam provided updated to the project.

## C. District Administration Office/Middle School Paving

Mr. Rick Gilliam reviewed the project that Mr. Chris Beauregard and Mr. James Bridges discussed concerning the paving project at the last Board meeting. He reviewed the timeline for the project.

# D. <u>Honeywell Presentation on Change Order 1 Components DAO Basement Ventilation, Security and Oak Flat Door</u>

Mr. Paul Yingling reviewed the Change Order Components for the District Administration Basement Ventilation project, security for all buildings, and the door at Oak Flat.

#### General Questions:

- 1. Mr. Fry informed the Board that the security is a concern with the wiring system.
- 2. Mr. Barrick asked if the new system will put nine cameras in the elementary buildings.
- 3. Mr. Fry stated the new system will have an in and out component to the system.
- 4. Mr. Wolf asked if it will be a wireless system.
- 5. Mr. Fry informed the Board that action will need to be taken at the next Board meeting to have the project completed on time.

- 6. Mr. Wolf inquired if the estimates are ball park figures for the wall or total project cost.
- 7. Mr. Fry told the Board there are less expensive alternatives for the door. At Oak Flat, we use that room a lot. This is a more expensive route but it does meet the needs for that room.
- 8. Mr. Wolf asked the life span for the door.
- 9. Mr. Wolf inquired if money is available to replace the door.
- 10. Mr. Piper questioned the sound track for the door.
- 11. Mr. Fry stated Instead of having six separate systems, this system will bring everything together into one system.
- 12. Mr. Wolf can the system be accessed off site?

## E. Mowing Contract 2014

Mr. Rick Gilliam will discuss the timeline for bidding the mowing project for 2014.

1. Mr. McCrea asked if the administration worked up a cost comparison so we can compare the two.
